MINUTES

ACTION ITEMS IN YELLOW

Welcome and introductions. Attendee list follows these minutes.

REMINDER: Dr. Julius Sokenu, Interim President at Moorpark College will be speaking at our **Feb 19 SCCRC meeting** on this work with the statewide CEO Racial, Equity and Inclusive Excellence Taskforce and how MC is responding to Chancellor Oakley's Call to Action.

Career Connect powered by Jobspeaker Presentation - Harriet Happel - Dean, College of the Canyons, Margaret Lau - Dean, Allan Hancock College, Paula Hodge - Regional Director, ICT/DM, Alma Miranda - College and Career Readiness Specialist (Business Partnerships) at Allan Hancock College)

- LinkedIn Learning is embedded with Career Connect
- As of February 1st, the 4 colleges that opted in will continue. Employers will be communicated out to all 8 colleges and information will be communicated via the scheduled events.
- They are doing more marketing of Career Connect across the region.
- When facing outwards, the terminology is "Career Connect powered by Jobspeaker." "Jobspeaker" is what the students understand.
- The work group is looking at logos to consider. The work group meets once a month.
- If anyone is interested in more information, reach out to Paula Hodge. At one time students had to create a LinkedIn profile in order to take advantage of LinkedIn Learning. That has been turned off, but students still have the option to create a profile.
- Antelope Valley College has a different application "College Central Network." Can the region market this as well as Jobspeaker to employers? As employers across the region join Jobspeaker, reports can be run so that Antelope Valley can see which employers in their area have joined Jobspeaker, and then AVC can contact them to invite them to create a platform in College Central Network. The dean who oversees job placement can reach out to all the Regional Directors.
- Allan Hancock College reported about the outreach that even extends to the community.
- College of the Canyons reported on the ease of joining the network. They no longer need



to use Excel to track placements as now almost all job placements are handled through Jobspeaker. The case management flags also relate to WIOA. Keri Aaver, Associate Director, Job Placement at College of the Canyons invited the 4 colleges that have not opted into Jobspeaker to connect with her regarding the functionality of the platform as well as learning about events. Jobspeaker is truly responsive in working with the region, unlike many other platforms.

K12 Strong Workforce Program Updates - Dr. Giselle Bice, K14 Technical Assistance Provider

- A survey has been pushed out to Round 3 participants. There will be another survey/needs assessment regarding needed professional development for teachers and administrators.
- The goal is to centralize professional development within each of the three sub-regions.
- K12 Pathway Coordinators are busy and making connections in their service areas.
- There is a project to organize the career pathways as well as A-G approval.
- Paula requested that Giselle check with each of the Regional Directors regarding the A-G approved courses in their sectors.
- Career Ladders Project will be engaged in pathway mapping in the region.
- There will be a professional development on equity and diversity and leading with empathy. This will be targeted to the three sub-regions.
- The Regional Chairs will set up some meetings particular to K12.

- The regional SWP Planning group reviewed and provided feedback and then the final draft went out to all SCCRC constituents for comment on 1.21.21
- Changes can still be made after submission to the Chancellors' Office on 1-29-21, as this will be a living document.

Regional Directors –

- **Business and Entrepreneurship**: Gayla Jurevich reported that our region participates in the Citi Ventures statewide project which has this Friday 1/29/21 from 10-11 a.m. information sessions.
- Dual Enrollment and articulated students can join in the project. **Contact Gayla for more information.**
- **ICT/DM**: Paula Hodge reported that the ICT group is working on a cybersecurity pipeline regionally and additionally partnering with the California Cybersecurity Career Education Pipeline and Pathway Project. Eventual need of assistance will be identifying Dual Enrollment or Articulation opportunities with cybersecurity in high schools and also supporting middle schools' cyber exploration.
- **Advanced Manufacturing**: Mike Bastine reported that there are two initiatives in Ventura County - Ventura County Industry Council (VCIC) is being formed. It will be a nonprofit entity collectively representing manufacturing industries in the county; The "Avenue Hardware Initiative" will be STEM production facility that will embrace the "Earn while you Learn" concept. Aspire 3, Westside Community Development Corp, STEMbassadors, a local business are key stakeholders of this initiative.
- **Global Trade**: Adilene Polis reported that they are working with the Port of Hueneme on what types of skills are needed for new employees. She is working with the economic development entity on a dashboard on what skills are in demand. Global virtual internship program. Registration is today. In addition, the Global Trade sector is spearheading a training with Microsoft.
- **Health**: Irene Ornelas reported that on February 5th there will be a cultural linguistic training for all faculty teaching in any course that is health related. It is open to K12 faculty as well. Contact her. Health Workforce Initiative (HWI) has been approached to help roll out vaccines at super-sites. They are looking for Medical Assistant (MA), Registered Nurse (RN), paramedic students to help administer vaccines. Ventura County public health and local (CNA) programs to be able to go back to skilled nursing facilities.
- **Ag Water and Environmental Technologies**: Holly Nolan-Chavez reported that the Acres 21 project in cooperation with Fresno State received a federal grant. This is a transferable pathway based in experiential learning. There are sub-committees at the K12 and community college levels. This is a new pathway, and they hope it can be scaled. Holly is hoping it can be linked with Jobspeaker. Career exploration app "100 careers to feed the planet and sustain the world" is being developed for the agriculture sector.
- **Energy, Construction and Utilities**: Dave Teasdale reported in the chat that the ECU sector is developing some internships with the National Renewable Energy Lab and with a Statewide Solar contractor for Solar, Construction or HVAC students.

4. **Center of Excellence (COE)** – this was tabled as Adele Hermann, Director of the regional COE could not attend the meeting today.

- Luann shared the link for requesting Looker reports in the chat. The tool is used primarily as a prompt with the goal of making sure that NOVA aligns with college general ledgers. SWP report generator at report.strongworkforce.net.
- Each college must request an extension beyond February 15th for reporting and/or input projects into Round 5. If the college fiscal office needs to have official permission from the CO for spending technically expired funds, they must request the extension from our region's monitor, Nick Esquivel.
- Question about how to proceed with "unfixable" things found during the NOVA reconciliation for regional projects. **Email questions to the RC team.**
- Question about Purchase Order showing date of commitment of ordering funds. The funds were encumbered in 2020, but not spent yet. If the college business office allows carry forward from round 1 to round 4, there is no problem with paying the invoice.
- Ventura matches NOVA budgets to reflect the reality of their spending. They do have to de-certify and re-certify plan in order to match the budget to expenditures.
- Tessa Miley, the former Chair of the North Far North and NOVA expert, will be available on Thursday, January 28th from 4:00 to 5:30 for questions. **Email the RCs and Amanda for the Zoom link.**
- Quarterly reporting for EWD must be approved by the CO project monitoring before being able to input the next quarter. Issues with getting CO approvals for all programs.
- Harriet shared about entering "across CTE" programs" into NOVA 2.0. She will use the TOP code that has the greatest enrollment to input to NOVA even though other sectors will be involved in the project—in order to meet the Jan 31,2021 timeline.
- Harriet and Robert will raise the "across all sector" 10% NOVA 2.0 dilemma with Sheneui at the CCCAOE Board meeting next week. They will report back to us. They will also raise the question about why K12 SWP still has 30 months to expend and community college SWP has been reduced to 24 months.
- **Luann will share the 10% proposal drafted by the Regional Chairs and sent to Sheneui and Sandra with the group.**
